«Now a paper peer-reviewed and published today should make every cardiologist question their support of COVID-19 vaccination with the reality that some patients have died with myocarditis sacrificing their lives for a vaccine without randomized trial data demonstrating reductions in viral transmission or adjudicated COVID-19 hospitalization, death or any hard outcome».

This is what the American cardiologist Peter Andrew McCullough writes (*in the cover photo, Source 1 – all sources at the bottom of the article*).

Autopsies confirm the massacre due to myocarditis caused by Covid vaccines

McCullough, former deputy chief of internal medicine at Baylor University Medical Center and professor at Texas A&M University, states in his article that official sources have always downplayed mRNA vaccine myopericarditis, or inflammation of the heart muscle and adjacent lining around the heart (pericardium), sustaining cardiac damage from vaccines is very high.

Hulscher et al, (Source 2) have just published in the European Society of Cardiology Heart Failure, a report on 28 cases of COVID-19 vaccine-induced myocarditis and concluded, based on the pathological findings, that death was caused by the injection.

*«Without vaccination, these patients with an average age of 44 years would be alive today. They further conclude, using the Bradford-Hill criteria, that cardiac death after vaccination can be inferred using epidemiological criteria, in other words, **unexplained cardiovascular deaths in vaccinees without prior underlying disease are probably [caused by vaccination](#)**».*

This is what McCullough adds that, using CDC VAERS, UK Yellow Card and EU EudraVigilance reporting systems, **also discovered 18,204 cases of myopericarditis reported as adverse reactions to mRNA gene sera.**

Other studies in [Germany](#) and [Japan](#) had confirmed numerous

deaths with a CERTAIN correlation between Myocarditis and mRNA vaccines.

18 thousand reports of Adverse Reactions for Cardiac Inflammation: 22% Lethal

A further review of the literature found dozens of well-documented fatal cases. This is what is reported in an article by **Lane et al.** (*Source 3*) From the database reported in the article report, it appears that the mortality rate was 0.22%, and in the peer-reviewed literature, [fatal outcomes occurred](#) between 0.41 and 45.85% of cases. While there is a wide range, even a 0.5% mortality rate when applied to a huge population with subclinical and clinical myocarditis producing large numbers of deaths in young people that are impossible to miss.

The Canadian government also admits 48,780 excess deaths in 2022, a 17% increase in mortality.

In the article published in Global Research (*Source 4*) it can be seen that 90% of the deceased people were vaccinated. **Doctor. William Makis** is a Canadian physician with expertise in *Radiology, Oncology and Immunology and a University of Toronto Scholar. In his recent research he highlights the increase of over 4000 deaths due to heart problems, as well as the significant increase of over 2000 cases [of turbo cancer](#), 2,000 tumors, 800 liver diseases, 500 kidney diseases, 500 diabetes.*

Therefore, it took hundreds of fatal events of myocarditis and pericarditis to get the European Medicines Authority (EMA) and the European Commission to admit, in the new version of Annex I to the decisions authorizing the placing on the market of the so-

called “vaccines ”-Covid-19 Comirnaty by Pfizer/BioNTech and Spikevax by Moderna, that **[these two mRNA-based substances cause deaths and other very serious irreversible damage!](#)** .

Currently, in a Machiavellian contradiction, we continue to support the reliability of this mRNA-based drug which continues [to cause sudden cardiac deaths](#) in a significant way, in the total silence of that part of [the judiciary that is inattentive to these problems](#), and of the mainstream who continue to keep your eyes closed to this human dripping.

10 thousand Sudden Illnesses for Mysterious Heart Problems in Australia

Precisely to demonstrate this correlation, at least statistically, some Australian scientists will build the largest database ever created in the world of deaths from sudden cardiac arrest, in an attempt to solve one of the most elusive and [frightening mysteries of cardiovascular diseases](#).

“The new super-registry, called CODEX-SD which links ambulance and forensic data, will for the first time give researchers their closest look yet at what causes sudden cardiac arrests and what might be done to stop them. A project supported by the Heart Foundation will combine and examine cardiac arrest data from two large existing databases.”

CODEX-SD will help researchers identify what further work needs to be done to unlock the genetic mysteries that made sudden cardiac arrest sudden, said Dr. Elizabeth Paratz of the Baker Heart and Diabetes Institute, project leader. a leading cause of death for people aged 50 and under in Australia.

In recent years, on average, in Australia, 25,000 people have suffered [an out-of-hospital cardiac arrest](#) and, in 30-40% of cases (or around 10 thousand) , doctors are unable to explain the cause.

“This lack of closure makes it incredibly difficult for families, but also with a lack of knowing who else might be at risk in the family adds another layer of distress. Dr Paratz said.

“90 percent of people who suffer a sudden cardiac arrest die, so if we can make inroads on that statistic – and we need to do so – one benefit, and the most important one, is that we have a better chance of keeping families together,” she said.

Also from Australian researchers comes the request for a temporary suspension for Covid-19 vaccines, in the face of an increase in excess deaths. “The majority of COVID-19 related deaths in Australia occurred between September 2021 and September 2022.”

While in 2020, fewer than 1,000 COVID-19-related deaths were reported in the country, a year later, in 2021, approximately 1,300 deaths were reported. [But in total, more than 10,000 excess deaths](#) occurred in 2021 .

“Therefore, approximately 90% of excess deaths were non-COVID deaths,” the researchers concluded, posing a very big question, which no authority has deigned to answer to date.

5 thousand vaccinated Italians destined to die of myocarditis

As reported in an article by *Naveen Athrappully* and published in ***The Epoch Times*** . These data are perfectly in line with Dr. Elizabeth Paratz’s project, two different studies that lead to the

same result, i.e. an NOT adequate prediction of the beneficial risks of a medicine administered to the world population too quickly and perhaps too superficially, dazzled by the enormous profit.

“We should pause, reflect and reaffirm essential freedoms, welcome the end of the COVID-19 pandemic, embrace natural immunity and lift all mandatory medical therapies.” Doctors say that they carry out this research autonomously and independently.

Request made [on 29 September 2023 by 7 MEPs including the Italian Francesca Donato](#), presenting a precise and detailed **“Priority question with request for written response P-002869/2023 to the Commission”** in which **the withdrawal of serum from the market is effectively requested** [anti-Covid mRNA genes](#) called **Comirnaty (Pfizer-Biontech) and Spikevax (Moderna)** .

The response is summarized in this sentence: “The Commission therefore does not intend to revoke the marketing authorizations for Comirnaty and Spikevax.” Reasoning that the pathologies of “... myocarditis and pericarditis are very rare, and respectively occur in less than one vaccinated person in 10,000...”.

They therefore confirm that almost **5 thousand Italians must sacrifice themselves to continue the vaccination campaign** where Piemonte inaugurated the [SEVENTH DOSE](#).

This is in fact the proportion of one death for every 10 thousand vaccinated based on official data published by RAI News which revealed a vaccination coverage of 90% on 59 million inhabitants.
