


And disabilities are up 10X normal. I thought the vaccines were supposed to reduce death not increase it! I just asked the FAA for their comment, but no answer.






So I reached out to the pilot who reported the 1 pilot death a month to learn more about the previous rate...

Excess deaths and disabilities are happening at every airline; not just limited to Southwest.



## The FAA wants a war, so I'm going to give them one

I'm not going to let the FAA get away with ignoring all the deaths and disabilities.
